The wait times for service are dependent on the volume of requests and can vary significantly. **Homeowners and guests must be ready to be picked up when requesting rides.** To limit wait times, the shuttle will not be able to wait outside any residence for unprepared groups. In these cases, the shuttle will have to move on to the next request in line.
